#### **COURSE OVERVIEW**

A multi-disciplinary, wide-ranging activity, covering several core competencies and designed to optimize the care of patients with diabetes by providing the knowledge base and practical tools necessary to help improve patient outcomes.

The program seeks to provide an opportunity for the participant to interact and network with other diabetes professionals. The course combines best practice strategies and education through case studies and lectures. The Harold Hamm Diabetes Care Summit is a one-day course that focuses on the management of the patient with diabetes. It is designed to address the unmet educational needs of physicians, mid-level providers and diabetes educators including registered nurses, registered dietitians and pharmacists who have a diverse case mix that includes patients with diabetes. The purpose of this conference is to promote excellence in care, and provide up-to-date information to enhance knowledge integral to the effective management of diabetes. Needs were identified from attendee evaluations submitted at the 2021 Harold Hamm Diabetes Care Summit as well as up-to-date medical journals pertaining to research and publications related to the treatment of diabetes and its complications. This CME/CNE/CPE seminar is needed because of the explosion of diabetes in our country. The number of persons with diabetes is expected to more than triple by 2050. According to the 2020 National Diabetes Statistics Report from the CDC diabetes affects 34.2 million people of all ages, which is 10.5 percent of the US population. The Oklahoma State Department of Health also reports more than 14 percent prevalence of diabetes in Oklahoma among adults ages 18 and older. In 2021, Oklahoma ranked the fifth highest in diabetes mortality rate in the nation. Because of the size of this problem and the complexity of managing patients with diabetes, this requires continuous training to health care professionals in order to meet the needs of patients with diabetes in our state and region. This course also combines best practice strategies and education through case studies and lectures.

#### TARGET AUDIENCE

Designed for individuals or groups of diabetes care and education specialists including RNs, RDs, Pharmacists, Physician Assistants, MDs, Social Workers and other health care providers interested in staying up to date on current practices of care for people with diabetes and other related conditions.

#### **SESSION TOPICS**

We've programmed a full day of topics relevant to a wide range of medical practices. They include promoting behavior change, exercise, technology, pharmacology updates, cardiovascular disease, practice management and diabetes and pregnancy.
